What data do we collect?

The Mustard Seed Christian Ministries may collect personal identification information (name, email address, phone number etc.).

How do we collect your data?

You directly provide us with most of the data we collect. We collect data and process data when you:		
	Voluntarily complete a form which asks for this information (e.g. donation form, gift aid)	
	Send us an email either direct from your account or via the email link on our website	
How will we use your data?		
The Mustard Seed Christian Ministries collects your data so that we can:		
	Respond to your enquiry	
	Email you with information that we think you might like (with your consent)	
	Set up or maintain a standing order that you have authorised	
	Claim Gift Aid in your name from HMRC that you have consented to	

How do we store your data?

The Mustard Seed Christian Ministries securely stores your data either on our computer or in a physical folder which is kept in the Mustard Seed shop (locked when no member of staff is present) or kept at the home/s of one of our trustees. Other information passed to our email address is kept securely on the cloud, accessed only by our email password which is known only by staff members, trustees, or others who have been specifically appointed by the trustees to manage our account.

We will keep your personal data for only as long as it is required, up to a maximum of 10 years. Once this time period has expired, we will delete your data by removing any trace of it – both digitally and physically – from our records unless you have consented to its ongoing storage either explicitly in writing or through the continuance of a standing order.

Marketing

The right to erasure: You have the right to request that The Mustard Seed Christian Ministries erase your personal data, under certain conditions.
The right to restrict processing: You have the right to request that The Mustard Seed Christian Ministries restrict the processing of your personal data, under certain conditions.
The right to data portability: You have the right to request that The Mustard Seed Christian Ministries transfer the data that we have collected to another organisation, or directly to you, under certain conditions.
